W@H Changes Coming into Effect

On April 1, 2024, changes to the Working at Heights Training Program Standard will come into effect. Some of the key changes include: Additional learning outcomes on required personal protective equiptment, ladders, skylights, and damaged equipment.

Sunburned retinas aren't the only potential risk from a solar eclipse.

On, April 8, 2024, a solar eclipse will be visible throughout Eastern Canada, including parts of Southern Ontario. There has been a lot of information with regards to the upcoming solar eclipse. While the eclipse will be temporary and short, it is important that anyone working outdoors during this time be aware of the risks and take precautions to minimize the risk of injury. That said, there was a great article, by Sharon Kirkey, of a hazard not being discussed. Canadian research suggests the risk of a fatality from a vehicle crash every 95 minutes from people rushing to view the celestial event.

New research suggests the total solar eclipse on April 8 could lead to about one extra person involved in a vehicle crash every 25 minutes, and one extra crash fatality every 95 minutes.

The study is based on data from a registry of fatal traffic crashes on public roads in the U.S. Canadian researchers focused on a three-day "exposure interval" centred around the day of the last total solar eclipse, in August 2017 — the day before, the day of and the day after.

The riskiest crash times weren't during the few minutes of totality, when the moon completely obscured the sun "and everything is black," said lead investigator Dr. Donald Redelmeier. It's in the hours before and especially the hours after," when people are rushing to get to prime celestial viewing spots on time or rushing to get back home, Redelmeier said.

The single riskiest hour was between 6 pm and 7 pm on the evening of the eclipse. So take care if you are driving at that period of time.

March 18 Guarding Critical Injury - Breadsource Corporation Fined 57,000

On the day of the incident, a temporary help agency worker contracted to work at the Company was assigned to a bread conveyor belt. The conveyor had rotating rollers and gears that were not equipped with guarding or other devices to prevent access to its pinch points. While adjusting bread on the conveyor, the worker suffered injuries.

The employer failed to ensure that measures and procedures prescribed by S 25 of Reg. 851 were carried out at a workplace contrary to S 25(1)(c) of the OHSA.

Mar 8 Working at Heights Critical Injury - Delta Elevator Company Limited Fined \$75,000

The electrical worker climbed a 13-tread flight of stairs from the broiler room. The landing at the top of the staircase had no barrier around the open side of the stairway as it had been removed by Delta workers to create room to move equipment.

After completing the installation of new lighting and other electrical equipment in the elevator room they cleaned the work area and threw cardboard waste down to the broiler room floor. While doing that, they fell nine feet to the floor below, sustaining injuries.

The employer failed to ensure the measures and procedures requiring a guardrail under S 26.1(1) of Reg 213 were carried out in the workplace, contrary to section 25(1)(c) of the OHSA.

Mar 6 Guarding Fatality - Stelco Inc. Fined \$200,000

While working alone, a worker noticed a a conveyor belt was slipping off its pulley attempted to fix the problem while the conveyor was still working. An investigation revealed the conveyor was in motion without a guard to prevent access to the head end of the machine at the time of the incident.

The employer did not ensure there was a means to safely apply belt dressing while the conveyor was in motion, as required under S 196(2)(a) of Reg 854 contrary to S 25(1)(c) of the OHSA.

Mar 6 Working at Heights Critical Injury - H&N Roofing & Sheet Metal Limited Fined \$75,000

A worker was injured after falling 15 feet through an HVAC opening in a roof. The only item covering the opening at the time of the incident was Styrofoam insulation.

The employer failed to ensure the worker was protected by appropriate fall protection and wearing protective headwear, as required by S 26.1(2) and 22 of Reg 213. This is contrary to S 25(1)(c) of the OHSA.

Feb 29 Lockout Critical Injury - Crystal Fountains Inc. Fined \$60,000

A worker was injured while setting up a milling machine to manufacture fountain nozzles. The machine should have had interlocks in place to prevent it from operating when its safety doors were open, but the interlocks had been removed.

The worker inserted a drilling jig into the machine's chuck and a cutting tool into the machine's cutting head, then entered a code into the machine's control panel to initiate an automated "warm up" of the cutting head. However, the worker entered the wrong code, which activated the chuck instead of the cutting head. This caused the chuck to spin and eject the jig, which injured the worker.

The employer failed to ensure the interlocks on the safety doors of the machine were maintained contrary to S 25(1)(b) of the OHSA.

MLITSD Certification Management System

The Ministry of Labour, Immigration, Training and Skills Development of Ontario (MLITSD) has launched a new Certification Management System (CMS) and will no longer be using SkillsPassTM.

What does this mean to you?

- In the past 3 years, all of Ministry approved training has been recorded and store on the old data base.
- They have transferred all of the data to the new CMS.
- All future training will now be stored on the new CMS

• There are going to be hiccups - It's new.

We would recommend to all of our clients who have received MLITSD approved training to logon to the new CMS to verify their data has been moved correctly. Data bases are dependent on how data was originally recorded and an error in email addresses etc. could cause multiple accounts or you failing to get your reminder that your certificate will be expiring. These certificates are your responsibility.

If you do not take a refresher course within 3 years you will need to do the full training course again for Working at Heights and Joint Health and Safety Certification Training which is a 5 day course.

Once you access this site you will also discover that you can peruse upcoming courses, check your validity for courses and enroll.







