New Inspectors are Coming

On September 23, 2020 the MLTSD launched a recruitment campaign to increase its team of frontline health and safety inspectors by 98 and help ensure workplaces across the province are doing their part to prevent the spread of COVID-19. With these new hires, there will be more labour inspectors on the ground than ever before in the province's history. The hiring of these new workers will see the number of active inspectors in the province increase from 409 to 507, an increase of 24 per cent. Training is set to begin later this fall.

The new inspectors will play a key role in protecting workers by checking and enforcing that workplaces are following occupational health and safety legislation. They will have broad powers to:

- inspect any workplace and ensure they have COVID protections in place;
- investigate any potentially hazardous situation, critical injury, fatality and work refusal;
- order compliance with the legislation;
- stop unsafe work from being performed; and
- recommend and initiate prosecutions.

Don't forget that the extension they gave to committees is due to expire, they will be checking to see if the training is compliant after Nov 30th.

Proposal to Recognize Alternative Fall Protection Training

In Ontario, workers who are required to use certain fall protection equipment on construction projects must complete Working at Heights (WAH) training approved by the Chief Prevention Officer. These requirements are set out in the Occupational Health and Safety Awareness and Training Regulation (O. Reg. 297/13), made under the Occupational Health and Safety Act.

The Ministry of Labour, Training and Skills Development is proposing to amend O. Reg. 297/13 to allow for the recognition of Fall Protection training approved by Workplace NL as an acceptable alternative.

In addition, the Ministry is proposing to expand an existing exemption so that it applies to more workplaces owned and operated by an automobile manufacturer or assembler, thereby eliminating the need for these auto sector workplaces to have two separate training programs for some workers who are directly employed by them.

The proposed amendments would maintain a high level of worker health and safety, support labour mobility and eliminate duplicative training costs.

Training Validity Extensions

Validity periods are extended for workers who were required to take refresher training for Working at Heights and Joint Health and Safety Committee between February 28 and August 31, 2020. WAH only

Validity periods are extended by one year for workers who were required to take refresher training for Working at Heights between February 28 and August 31, 2020. You are encouraged to register for training as soon as possible. Log in to your SkillsPassTM account to check your status. Click here to set up your free account.

JHSC only

Validity periods are extended until November 30, 2020 for workers who were required to take Joint Health and Safety Committee refresher training between February 28 and August 31, 2020. You are encouraged to register for training as soon as possible. Log in to your <u>SkillsPassTM account</u> to check your status. Click <u>here</u> to set up your free account.

CONFINED SPACE TRAINING

All students whose Safetyscope Confined Space Rescue qualifications were due to expire from 1 March 2020 onwards, have had their qualifications extended until 31 January 2021, as a result of the COVID-19 pandemic.

We recognize that different regions in Ontario have different levels of restriction, based on local infection rates. It may still be possible for students to undertake training courses in some areas, with an appropriate COVID-19 risk assessment and associated control measures we provide.

Workplace COVID Screening is Mandatory

Since the reopening process began, regulatory authorities across Canada have made it clear that employers may implement screening measures to prevent COVID-19 infections in the workplace. Some agencies have even recommended screening as a health and safety measure.

On September 26, Ontario became the first province to require workplace screening. There are 6 FAQs explaining the new law and what it does and doesn't require.

Is the JHSC Inspecting all of Your Fire Safety Controls?

It is widely understood that your organization must properly maintain fire extinguishers to keep your team and business safe. This includes monthly visual inspections and annual maintenance. But lets not forget to inspect the other safety devices in your workplace monthly. The following is a list of controls that should be included in all JHSC inspections:

- emergency lighting
- exit signs
- fire extinguishers
- kitchen systems and other special hazard fire protection
- Sprinkler systems

The JHSC should also clarify if staff are receiving training on how to use fire extinguishers.

Worker Fined \$10,000

We have watched the penalties for the employer and supervisors escalate in the past two years but are penalties increasing for workers? It is not often that workers fines are published in the MLTSD court bulletins and as such was worth noting.

A person in a room below an area undergoing renovations was struck by debris from through the ceiling, where a worker was cutting through the floor. The injured person required medical attention and experienced issues related to the injury. The defendant worker failed to ensure that the core drilling system was used in accordance with the manufacturer's operating manual.

Section 93(3) of Reg. 213/91 states "all vehicles, machines, tools and equipment shall be used in accordance with any operating manuals issued by the manufacturers."

By failing to ensure that the area below the floor where the drilling was taking place was secured, the defendant failed to work in compliance with the provisions of the regulation, contrary to section 28(1)(a) of the OHSA.

In the Courts



Why should you follow prosecutions for violations of the OHSA and Regulations?

The MLTSD prosecutes persons, including corporations, for violations of the OHSA and its regulations to ensure compliance and to deter non-compliance. The courts had a brief hiatus but they have started up again.

Aug 24 2020 Worker's Propane Burns - Parkland Fuel Corporation fined \$150,000

A worker suffered burns while transferring propane from a tank truck to propane tanks at a private residence.

Workers are required, under the TSSA to have a certificate or a record of training before operating a propane tank truck or engaging in the process of transferring propane from a truck to a propane tank on customer premises. Parkland had held off training until several newly-hired workers could be trained together.

Parkland failed as an employer to provide information, instruction and supervision to a worker to protect the safety of the worker, contrary to s 25(2)(a) of the OHSA.

Sept 21, 2020 Crush Injuries - Imprimeries Transcontinental 2005 S.E.N.C fined \$65,000

A worker suffered critical injuries from being pulled into printing press.

The incident was investigated and determined that the injured worker had not been trained on the hazards associated with not safely locking out the press machine. Further, workers were not provided with locks to ensure controls are locked out. Only maintenance personnel were provided with locks.

As such, the company contravened s 25(2)(a) of the OHSA by failing to provide information, instruction and supervision to a worker in relation to safety locking out a drive shaft on a press machine.

Sept 21, 2020 Fall From Platform - Aurora King Masonry Ltd. fined \$60,000

A worker received critical injuries after falling from a platform.

A MLTSD inspector determined that the elevated work platform in question did not have a guardrail. Aurora King failed, as an employer, to ensure that the measures and procedures prescribed by s 135(1)(c) of Reg. 213/91 were carried out at a construction project, contrary to s 25(1)(c) of the OHSA.

Sept 21, 2020 Fatality Crushed by Object - Orin Contractors Corp. fined \$125,000

A worker was killed when the scoop bucket attachment on an excavator fell on the worker.

The company pleaded guilty to failing, as an employer, to ensure that the measures and procedures prescribed in s 93(3) of Reg. 213/91 - the Construction Projects Regulation - were carried out in a workplace located at or near Verdun Road, Oshawa, contrary to s 25(1)(c) of the OHSA.

Sept 22, 2020 Critical Injury Crushed by Object - Sellick Equipment Ltd. fined \$40,000

A worker suffered critical injuries when a steel bar fell from an industrial magnet.

Although the worker had received on-the-job training from Sellick, the worker had not received formal overhead crane training, nor had the worker received or reviewed the operating manual for the magnet. Sellick failed to maintain a lift magnet in good condition, contrary to s 25(1)(b) of the OHSA.

Oct 2, 2020 Fatality Fall from Roof - Welldone Inc. \$150,000

A worker fell from the roof of the building and was killed by the fall.

The workers were on the roof top marking measurements to indicate the new location for a beam to support the suspended swing stage. The worker took the zero end of the measuring tape and had walked away towards the end of the wing to mark the location of the beam and then fell off the edge of the building. The defendant failed to ensure a worker was protected by a means of fall protection outlined in s 26.1(2) Reg 213 and thereby violated s 25(1)c of the OHSA.

In the Courts



Oct 6 2020 Critical Crush Injury - Green Belting Industries Limited fined \$60,000

A worker was injured when a roll of paper slid from a lifting device that should not have been used.

Reg. 851 stipulates that an employer must ensure that material, articles or things are transported or stored so that they will not tip, collapse or fall [(s 45(b]). The defendant failed to ensure that the rolls were transported in a manner where they would not tip, collapse or fall, contrary to s 25(1)(c) of the OHSA.

Oct 13, 2020 Stuck by Injuries - City of London fined \$70,000

Worker Struck by Exploding Cap, \$70,000 Fine for City of London

A worker was injured when a cap on a drain pipe shot off and struck the worker, resulting in critical injuries.

The investigation that followed determined that the Corporation of the City of London committed the offence of failing, as an employer, to take every precaution reasonable in the circumstances for the protection of a worker, which is an offense under the OHSA. Specifically, the employer failed to take the reasonable precaution of ensuring that the internal pressure of the drain pipeline was released before the mechanical joint end cap was removed and/or loosened. This was contrary to s 25(2)(h) of the OHSA.

Oct 16, 2020 Electrocution Fatality - Great Lakes Greenhouses Inc. fined \$120,000

A worker received critical injuries after falling from a platform.

A MLTSD inspector determined that the elevated work platform in question did not have a guardrail. Aurora King failed, as an employer, to ensure that the measures and procedures prescribed by s 135(1)(c) of Reg. 213/91 were carried out at a construction project, contrary to s 25(1)(c) of the OHSA.

Oct 16, 2020 Workplace Violence Injuries-Southlake Regional Centre Fined \$80,000

Two workers were injured as a result of workplace violence exercised by a patient.

The MLTSD inspectors found that while Southlake did implement some policies dealing with workplace violence in the MHWA, several hazards remained for which the employer had failed to conduct a proper risk assessment to determine what reasonable precautions were needed to the protect the safety of the workers.

Southlake failed, as an employer, to take the reasonable precaution of establishing effective means of communication between workers in the nursing station and persons in the common area of the MHWA, contrary to s 25(2)(h) of the OHSA.

Furthermore, on January 17, 2019, Southlake failed, as an employer, to take the reasonable precaution of developing and/or establishing a procedure for the safe entry to and/or egress from the common area of the MHWA when a person is presenting with escalating behaviour, contrary to S 25(2)(h) of the OHSA.

First Aid Certification Extension

The Ontario government recently announced that first aid providers in certain regions will be included in phase two of reopening the province, and have permission to reopen and resume in-class first aid training.

The WSIB is working closely with all of their first aid providers and have developed resources and protocols to ensure that we can safely restart in-person training as soon as possible.

While in-person training is now being permitted, the WSIB is encouraging providers to continue delivering blended training where it is possible to do so. The WSIB is also encouraging first aid providers to prioritize access to people and organizations working in front line, essential services.

WSIB is also extending recertification and certification until Dec 31, 2020.
