

## It Can Happen Anywhere

Confined space training is a crucial part of keeping employees safe. It is the employer's responsibility to assure that all employees working in or around confined spaces have been properly trained. Could these deaths have been prevented?

January, 2018 - One man killed, another injured in Hamilton industrial accident. A worker was trapped inside a tanker truck in the industrial north end and was pronounced dead due to a lack of oxygen caused by nitrogen inside the tanker he was in. His co-worker survived.

2017 - A worker died after industrial accident at Oakville container business. While working in a confined space a worker was found unconscious, and was pronounced dead at the scene.

## Confined space: What have you got?

O. Reg. 632/05: Confined spaces defines "confined space" as a fully or partially enclosed space,

- a) that is not both designed and constructed for continuous human occupancy, and
- b) in which atmospheric hazards may occur because of its construction, location or contents or because of work that is done in it;

Federal legislation on confined spaces, which governs industries that operate inter-provincially such as pipelines, railways and grain companies, uses the same definition as the CSA standard, saying a confined space is also one that "may become hazardous to any person entering it."

Canada Occupational Health and Safety Regulations PART XI Confined Spaces defines "confined space" as an enclosed or partially enclosed space that

- a) is not designed or intended for human occupancy except for the purpose of performing work,
- b) has restricted means of access and egress, and
- c) may become hazardous to any person entering it owing to
  - i. its design, construction, location or atmosphere,
  - ii. the materials or substances in it, or
  - iii. any other conditions relating to it;

#### Critical Injury Falling from Ladder

Santoro Construction Inc. fined \$90,00 when a worker fell from a ladder and suffered critical injuries while performing electrical wiring work on a renovated office site.



Santoro Construction Ltd. was the constructor of the project at 27 Fasken Drive and had contracted with GMJ Electric Inc. to carry out all the electrical installations.

The worker and a co-worker were tying in and labelling electrical wiring in the ceiling of a renovated office area. The worker was working on the top third rung of a 10-foot step ladder and reaching into an area above the grid of a drop ceiling. The worker fell from the ladder to the floor, suffering critical injuries.

A constructor is to provide a worker with a scaffold, a suspended work platform, a boatswain's chair or a multi-point suspended work platform in situations where work cannot be done on or from the ground without hazard to workers.

#### Death of Pedestrian Results in \$195,000 Fine to Sudbury Company

Interpaving Limited was fined \$195,000 after a pedestrian was killed after being struck by a road grader that was reversing. The operator's visibility was restricted due to a blind spot and the operator was not being assisted at that location by a signaller or a paid-duty police officer.

Interpaving and the City of Greater Sudbury failed to comply with section 104(3) of the Construction Projects Regulation (Ontario Regulation 213/91) which states that "operators of vehicles, machines and equipment shall be assisted by signallers if either of the following applies: 1, the operator's view of the intended path of travel is obstructed; and 2, a person could be endangered by the vehicle, machine or equipment or its load."

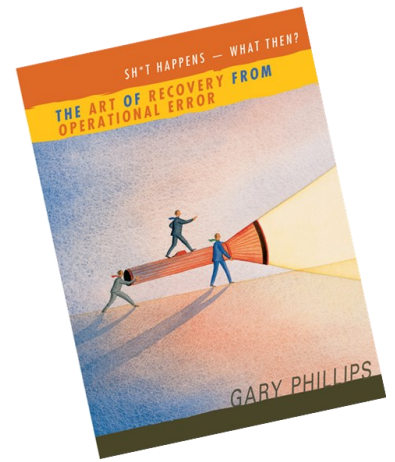
