Site Supervisors

Competent supervisors, enable employers to have the oversight and control over health and safety in the workplace to ensure everyone returns home safely after a day's work and helps establish their due diligence in regards to workplace health and safety.

A construction site is a changing environment every day and a worker might be a supervisor one week and be back to a labourer the next.

Under the OHSA, a supervisor is required by any contractor with more than five workers — an obligation some small employers aren't aware of.

Make sure your supervisors have the training to understand the legislation and possible repercussions if the law is not complied with.

May 31, 2019 Two Companies and Site Supervisors Fined \$677,500

Claridge Homes, the builder, and Bellai Brothers Construction Ltd., firm responsible for the project's structural concrete work failed to ensure the walls of the excavated area were stripped of loose ice that could fall and hit a worker.

About six weeks before the fatal incident, another Bellai Brothers worker was hit by ice but not seriously injured, according to the Ministry of Labour. The incident was reported, but an inspector deemed that sufficient ice removal precautions were being taken. Workers were also warned to watch for ice, as well as to stay clear of the south wall.

Tasked with preparing for a new footing at the bottom of the excavation, a worker was hit by a falling piece of ice weighing an estimated 56 kilograms and stretching four metres long. It fell from near the top of the pit below the netting.

After the job site had been cleared, the ministry noted, another large piece of ice fell from the same location on the south wall.

Along with fines of \$325,000 for each company, supervisors with Claridge and Bellai Brothers were fined \$12,000 and \$15,000, respectively.

Joint Health and Safety Committee Refresher

JHSC Refresher Training is required to maintain JHSC certification for anyone who became certified after March 1, 2016.

This training will review key concepts and learn about updates to health and safety legislation and standards and must be completed within three years of completing JHSC Part 1 & 2. After that, JHSC Refresher must be completed once every three years from that date in order to remain a certified JHSC member.

Failure to take the refresher course could result in the certified members being required to repeat the 5 day certification course.

Ministry of Labour Specialized Professional Services - Municipalities and Ergonomics

Rational: Municipalities have above-average lost time injury rates and musculoskeletal disorder rates, and they have not been a focus of ergonomics initiatives before now.

The MOL develops annual sector-specific enforcement plans related to workplace hazards and describes the focus of inspectors. The Specialized Professional Services Work Plan outlines the ministry's enforcement initiatives to protect Ontario's workers from occupational injury and illness.

Engineers, ergonomists, hygienists and radiation protection officers support the construction, health care, industrial and mining sector initiatives, including two all-sector initiatives for: slips, trips and falls and musculoskeletal disorders (MSDs) and respiratory diseases

Phase 1: Compliance assistance April 1, 2018 to March 31, 2020

In April 2018, a letter was sent to all municipalities with greater than 50 full time equivalent employees to inform them about the initiative and invite them to attend an information webinar. Two information webinars were held in May 2018, with presenters from the Ministry of Labour and PSHSA providing information about the focus of the initiative and the type of support PSHSA would be able to provide municipalities. One webinar was recorded and posted on the PSHSA website and a frequently asked questions document was also developed and posted on the PSHSA website.

Phase 2: Focused inspections April 1, 2019 to March 31, 2020

Ministry of Labour ergonomists will perform an administrative review and physical inspection(s) for each municipality visited. The administrative review will focus on the entire municipality, while the physical inspection will focus on the public works department.

Initiative focus: Ergonomists will focus on the following key priorities:

- musculoskeletal disorder (MSD) prevention
- contact with and struck by hazards that are due to visibility issues while operating vehicles and mobile equipment
- falls due to a worker not being able to maintain their balance while working (e.g. from a ladder)

Ministry of Labour ergonomists will also focus on workplaces that have a history of MSDs. A list of workplaces will be developed from Workplace Safety and Insurance Board data and workplaces will be looked at based on their MSD history and whether or not they have received a previous proactive inspection focusing on MSD prevention.

May 24, 2019 Best Way Stone Limited fined \$55,000 for Worker Injury

A worker received critical injuries after being pushed into a lift table when a conveyor

carrying transfer boards loaded with paving stones resumed moving through the production line. The moving stack of boards struck the worker and pushed the worker into a lift table, resulting in critical injuries.

Section 25(1)(c) of the Occupational Health and Safety Act (OHSA) provides that an employer shall ensure that the measures and procedures prescribed by the act and regulations are complied with at the workplace.

Best Way Stone failed to ensure that the exposed moving parts of the de-stacker and associated chain drives were equipped with and guarded by a guard or other device that prevented access to the moving parts, contrary to section 24 Regulation 851. This is an offence pursuant to section 66(1) of the OHSA.

May 16, 2019 Highline Produce Limited fined \$75,000 for critical injury

Workers were conducting "filling operations" in a mushroom "grow room." This task involves using a hydraulic winch to pull netting along the mushroom grow beds, filling the beds with compost as it does so. These winches are called "net winch pullers."

While guiding the cables into the winch, the worker was caught by one of the cables as it wrapped around the roller of the winch assembly. The worker was entangled and pulled into the winch assembly which formed a pinch point. The worker suffered a critical injury as a result.

Highline failed to take the reasonable precaution of ensuring that the hydraulic net winch puller on Row #3 in that grow room was equipped with and guarded by a guard or other device that prevented access to the pinch point, contrary to section 25(2)(h) of the act. This is an offence pursuant to section 66(1) of the act.

May 9, 2019 Clean Water Works Inc. fined \$100,000 for conveyor injury

The worker was pulled into the pinch point of an in-running nip hazard created by two rollers on a moving conveyor known as the wet-out plant conveyor.

An investigation of the incident by the Ministry of Labour concluded that Clean Water Works Inc. failed to ensure that the in-running nip hazard on the machine known as the wet-out plant conveyor was guarded by a guard or other device that prevented access to the pinch point. This was contrary to section 25(1)(c) of the Occupational Health and Safety Act.

May 7, 2019 5:00 Steven Bell, sole proprietor of a roofing company in Belleville, Ontario. incarcerated.

A Ministry of Labour inspector observed a roofing project on a residence in Belleville. The inspector observed that a roofer, employed by Bell, was working on the roof at a height in excess of more than three metres from the ground. The worker was not wearing any means of fall protection. There were no injuries. Bell has three previous convictions under the OHSA for exactly the same offences

In 2013, an inspector observed 3 roofers in Belleville, working at heights of more than 3m without being protected by fall protection. The \$2,000 fine has not been paid. Again in 2013, an inspector observed 4 roofers without fall protection. There were no injuries. A \$4,500 fine was levied, of which \$900 remains unpaid.

In 2015, an MOL observed a roofer without being protected by fall protection. There were no injuries. For that offence, Bell was sentenced of one day of imprisonment and a fine of \$10,000, which has not been paid.
