

COURSE	CONTENT	CLASS SIZE
Confined Space Attendant	This course is designed to prepare the worker to enter a space safely as well as perform the role of the Attendant on the outside. The course covers legislation, hazard recognition and control and documentation. The Attendant course covers atmospheric monitoring, ventilation and non-entry rescue as well. Every effort is made to customize this course to the client's specific needs.	Awareness Max 20 Attendant 8 - 10 (Max 12)
Confined Space Rescue	This course further develops your attendant skills and teaches you, in your role as a rescuer, how to create a rescue plan. We give you the skills required to put that rescue plan in place and safely enter the confined space to retrieve a downed worker. This course covers the use of supplied air, rope skills, patient assessment and packaging as well as incorporating proper body mechanics to prevent injury. Our goal is to prepare your team to set up and apply your equipment for a successful rescue should you be called into action.	8 - 10 (Max 12)
First Aid	We offer both Red Cross and ECIS programs. Both are WSIB approved. These courses teach participants how to recognize a first aid emergency. They cover basic first aid treatment and CPR as well as use of AED.	6 - 12 participants
WHMIS	WHMIS covers the 6 classes of hazardous chemicals and their dangers, supplier and workplace labels as well as MSDS. This course will cover: <ul style="list-style-type: none"> • Responsibilities & Exemptions • Hazardous Materials & Consumer Products • Material Safety Data Sheets • Health Effects and Routes of Entry and Exit • Labelling - Supplier and Workplace Labels • Introduction to the Global Harmonized System (GHS) 	Maximum 20
Working at Heights	This course is designed to make the worker aware of the fall hazards in the workplace. It covers hazard recognition, legislation, anchorage connectors and the various pieces of fall protection equipment. There is a large portion of hands on demonstration including harness inspection and proper donning. This program meets the New Working At Heights Standard and is approved by the Ministry of Labour.	Maximum 12
JHSC Part 1 Certification Training Course	This MoL approved Part 1 Certification course was developed by Dwight Barratt Associates Inc. specifically to address the curriculum requirements for certified members of Joint Health and Safety Committees, Health and Safety Representatives, Health and Safety Coordinators, supervisors, managers and workers. Upon successful completion of the Part 1 training course and the subsequent workplace specific training courses which are identified by their employers, the participants will have satisfied the requirements for certified members utilizing Ontario JHSC training, mandated by the WSIB.	Maximum 20
Competent Supervisor	This workshop provides supervisors, lead hands, managers and owners with the skills and knowledge required to manage and implement health and safety in their respective roles as required by Bill 160. On completion of this course you will be familiar with your legal responsibilities with regards to work refusals, injury reporting, and critical injuries and understand the roles of all workplace parties. You will be aware of all recent changes in the OHS.	Maximum 20
