October is Fire Safety Month

Is your workplace or home fire proof?

Eliminate Clutter – Clutter can easily become a fuel source in the event of a fire, allowing a fire to spread quickly. Furthermore, clutter can restrict access to emergency equipment and exit routes.



Fire Extinguishers – Maintain the appropriate type and number of fire extinguishers.

- Conduct monthly and annual extinguisher inspections to ensure they are in good, working condition.
- Provide training for employees on the correct use of fire extinguishers.
- Chemical Safety Read hazard warning labels and safety data sheets to determine flammability and other fire hazards. Ensure your chemical storage areas provide adequate ventilation for the storage of chemical or other hazardous substances.
- **Waste Control & Storage** Limit the accumulation of flammable or combustible materials and residues as to prevent the risk for such materials contributing to a fire emergency.
- Exits Ensure emergency exit route diagrams are posted and accessible in all areas of the facility for all employees to easily view. Additionally, ensure means of egress are well-lit with regulated exit signs and free from debris or clutter.
- **Contact Information** Employees should have access to a list of emergency contact phone numbers in case of emergency. Remember that human nature is to panic in emergency situations; therefore, basics such as the company address, important phone numbers, and building floor plan should be posted on or with the emergency action plan.

Court Bulletins Critical Injuries

Oct 17 Inadequate Brace Injury - Andritz Hydro Canada Fined \$80,000

Two millwrights were correcting an installation performed earlier, of three metal sole plates to the underside of a stator frame. After removing the bolts the support jack released and a sole plate tipped inwards critically injuring a worker who was struck by the falling sole plate.

By not ensuring the sole plate was adequately braced, the employer failed to ensure that the measures and procedures were carried out at the workplace, contrary to S 25(1)(c) of the OHSA.

Oct 9 Crane/Lifting Injury - Innovative Metal Works Inc - Fined \$68,000

Three workers were erecting steel for a new three-story addition. One worker was at ground level rigging loads to a crane to be hoisted and the other workers were on the third level with two scissor lifts used to install and connect the beams once hoisted. The ground-level worker connected one end of a nylon hoisting strap to the centre of a lateral assembly beam with a choke hitch and attached the other end of the nylon hoisting strap to the crane hook block. The crane then lifted the beam to be placed and connected.

The lateral assembly beam, still being moved by the crane, was near its final position and ready to be bolted into place when the nylon hoisting strap holding it to the crane broke, causing the beam to swing and fall critically injuring the ground-level worker.

An investigation found that the nylon hoisting strap used to hoist the lateral assembly beam was cut when it came into contact with the sharp capping plate on the assembly. The employer, failed to ensure that the measures and procedures were carried out in the workplace, contrary to S 25(1)(c) of the OHSA.

Bill 190, Working for Workers Five Act, 2024

What is the Minister of Labour, Immigration, Training and Skills Development of Labour's Focus at this time? On Oct 9 Bill 190 passed 2nd Reading and the explanatory notes of the sections indicate the content:

Schedule 1 - Building Opportunities in the Skilled Trades Act, 2021

• Amends to provide that the regulations may set out alternative criteria for academic standards.

Schedule 2 - Employment Standards Act, 2000

The **Employment Standards Act**, 2000 is amended as follows:

- New sections 8.5 and 8.6 of the Act establish certain requirements with respect to publicly advertised job postings. Complementary amendments are made to the record-keeping requirements in section 15 and the regulation-making authorities in subsection 141 (1).
- Section 50 of the Act is amended so that employers retain the right to require evidence of entitlement to sick leave but are not permitted to require a certificate from a qualified health practitioner.
- Section 132 of the Act, which sets out the fines applicable for convictions under the Act, is amended to increase the maximum fine for an individual to \$100,000.

Schedule 3 - Fair Access to Regulated Professions and Compulsory Trades Act, 2006

Adds new sections requiring regulated professions to have policies respecting what alternatives to the documentation of qualifications that is normally required will be acceptable and to have plans addressing how they will enable multiple registration processes to take place concurrently. The sections also include requirements respecting the contents of the policies and plans and other related provisions.

Schedule 4 - Occupational Health And Safety Act

- The Act is amended to impose duties on constructors and employers with respect to the maintenance of washroom facilities. Complementary amendments are made.
- The definitions of "workplace harassment" and "workplace sexual harassment" are updated to include certain virtual activities.
- Section 3 of the Act is amended to provide that the Act applies to telework performed in or about a private residence.
- Various provisions of the Act that require the posting of information are amended to provide that the information may be posted in a readily accessible electronic format. New subsection 1 (5) establishes the requirements that must be met for information to be posted in a readily accessible electronic format for the purposes of the Act.

Schedule 5 - Ontario Immigration Act, 2015

• Amends to provide that an individual who is appointed to conduct an internal review may delegate the individual's powers or duties under the appointment.

Schedule 6 - Workplace Safety and Insurance Act, 1997

- Section 14 of the Act, which provides that certain workers are entitled to benefits under the insurance plan for posttraumatic stress disorder arising out of and in the course of the worker's employment and that the posttraumatic stress disorder is presumed to have arisen out of and in the course of the worker's employment, unless the contrary is shown, is amended to include two new categories of workers. Transitional matters are provided for and complementary amendments are made.
- Section 15.1 of the Act, which creates presumptions that apply to certain firefighters and fire investigators, is amended to establish a presumption in respect of primary-site skin cancer. Related amendments are made to provisions of that section and to section 15.2.

We will keep an eye out to inform you when and if this Bill passes third reading.

Court Bulletins Fatality

Oct 9 - Lack of Guarding - Gwillimdale Farms Ltd., Fined \$125,000.



Workers were preparing the Potato Line, a custom-designed system of hoppers, conveyors, cleaners and packaging equipment, for start-up. This included lubricating the line, which is done with the machinery running. After the lead millwright went home, a trainee who was assigned other duties began lubricating the Potato Line alone and suffered fatal injuries.

An investigation found that the line's uptake conveyor was not equipped with a guard to prevent access to the pinch point and the employer failed to ensure the measures and procedures prescribed by S 25 of Reg. 851 were carried out in the workplace, contrary to S 25(1)(c) of the OHSA.


